Eligibility

I understand that in order to participate in ELIS FOR ALL 2026, I must provide evidence that I have been an employee for at least three months as of the opening date of the subscription period (15 September 2026), and that I still need to be an employee of the Group on the closing date of the subscription period (1 October 2026)

Payment into the Savings Plan:

I note that my subscription is being made as part of a Savings Plan, to which my subscription constitutes membership, and that the Elis shares I am subscribing for will be held through the company mutual fund (FCPE) 'Elis for all relais 2026', set up for the purpose of subscribing for Elis shares to be issued as part of the capital increase reserved for employees who are members of a company or group savings scheme, as decided by the Management Board on 31 March 2026 and 29 July 2026, in accordance with the authorisation granted by the Supervisory Board on 16 December 2025 and reaffirmed on 30 July 2026, as well as the delegation of powers granted to it under the terms of the 24th resolution approved by the combined general meeting of Elis shareholders on 21 May 2026. I will receive a number of units in the 'Elis For All Relais 2026' company mutual fund (FCPE) proportional to my investment. These FCPE units will be locked up for a period of three years from the date of delivery of the shares to the FCPE, except in cases of early release provided for by the regulations and described in the information prospectus.

ELIS FOR ALL 2026 offer payment cap

I understand that my subscription is capped at €50,000. I undertake to ensure that my total payments into the Elis International Group Savings Plan (Plan d'épargne Entreprise International – PEGI), or into any savings plan to which I have access, do not exceed 25% of my gross annual salary. I understand that the minimum amount for subscription of a unit of the "Elis For All Relais 2026" FCPE is €50. If my subscription is below €50, it will not be taken into account.

Information on the ELIS FOR ALL 2026 offer:

I acknowledge that I have referred to the documents that I obtained from the Human Resources Department or those accessible on the website, and in particular the brochure and the key investor information documents (KIID) for the "Elis For All Relais 2026" FCPE and the Elis PEGI.

This will be set at the reference price (the average price from the 20 trading days prior to 11th September 2026) minus a 30% discount. I understand that any dividends that may be paid by Elis will be automatically reinvested in the FCPE and new units will be created in my name.

I understand that the "Elis For All Relais 2026" FCPE is not open to "US Persons" and as such I confirm that I am not a resident of the United States of America. I acknowledge that I have been informed that:

- my subscription cannot be taken into account if my declarations are inaccurate (amount of my subscription and my gross annual salary)
- my subscription cannot be taken into account if I do not satisfy the condition of being an employee for at least three months as on the first day of the subscription period (15

September 2026) - my subscription cannot be taken into account if I do not satisfy the condition of presence on the last day of the subscription period (01 October 2026)

- in the event of a payment default or insufficient funds, my employer reserves the right to instigate any legal proceedings against me to recover the unpaid amounts. I irrevocably permit my employer or the custodian of the "Elis For All Relais 2026" FCPE to repurchase or order the repurchase of, without prior notice or notification, all FCPE units that I hold, in accordance with the applicable regulations, and to allocate the proceeds therefrom, in the correct amount, to the settlement of the amounts corresponding to my subscription, inclusive of fees for the recovery of said amounts.

Processing of personal data

This information will be used to process my subscription request and to manage my investment until the cession of my FCPE units. My personal data will be stored for the purposes of data processing, for the necessary amount of time as of the start of the 2026 scheme, and for managing the Elis PEGI. This will be at least until the cession of all of my units of the "Elis For All Relais 2026" FCPE, and later for the purposes of archiving until the expiry of the limitation period for any dispute relating to this data.

that these issues would not compromise my subscription commitment under this ELIS FOR ALL 2026 subscription bulletin.
